The cookies we use

The table below explains which cookies we use on our website, why we use them and whether they are essential or a different type of cookie, such as 'function' or 'performance' cookies. We also indicate in the table whether a cookie is a "persistent" or a "session" cookie. The difference between the two types is:

Persistent cookies remain on your device between browsing sessions. They are activated each time you visit the website that created that cookie. For example, if a "persistent cookie" is used on a website that remembers your login details, you do not have to enter them every time you visit the website.

Session cookies allow website operators to link a user's actions over the course of a browsing session. A browsing session begins when you open a browser window and ends when you close the browser window. Session cookies are only temporary. Once you close your browser, all session cookies are deleted.

Some of the cookies listed below are set by our own website when you visit www.lang-coach.com. However, we also have cookies on our website that are set by third parties. For example, in order for us to play YouTube videos through our website, YouTube sets cookies on www.lang-coach.com (for more information on how YouTube uses cookies and what information is collected, please visit http://www.google.com/policies/privacy/.

yabs-sid	Analytics	These are cookies used by Yandex Matrica script belonging to the company Yandex. This cookies are used to measure and analyse the traffic of the website by giving information about how the users use the website.	session
